Study to assess the incidence of COVID-19 in Quebec -Updated with data from the week of April 28 to May 3rd, 2022



The update of the CIRANO study to estimate the incidence of COVID-19 cases in Quebec shows a significant decrease for this 16th week of collection, which took place from April 28 to May 3rd, 2022, compared to the previous week. The number range from 18,000 to 40,500 cases per day, depending on the estimation method used.
